SUBJECT: Air Force Reserve Selected Reserve JAG and Chaplain Captain and Major
Selective Continuation Boards, 22 April 2003

Attached are alphabetical listings of the Air Force Reserve officers selected or nonselected for continuation on the Reserve Active Status List (Atch 1-4). The continuation board convened in accordance with Title 10 USC; DoD Directive 1320.8; Air Force Policy Directive 36-26; and Air Force Instruction 36-2504 at Headquarters Air Reserve Personnel Center (HQ ARPC).

Public release is 1 July 2003 and was announced by DMS message. Do not inform officers of their status until public release date. The select and nonselect lists are "For Official Use Only" and may not be seen by anyone other than those officials who are responsible for the administrative processing of the lists. Individuals selected for continuation will be notified by letter from this headquarters to either accept or decline the continuation. Do not publicly display or release either select or nonselect lists at anytime.

Military Personnel Flights (MPFs) will furnish unit commanders the names of their officers selected and nonselected for continuation. Commanders must continue to evaluate officers and ensure propriety of continuation. If it becomes appropriate to remove an officer's name from a select list, comply with AFI 36-2504 chapter 10. Such actions must be initiated prior to officer accepting continuation. Selected captains and majors may be continued on the Reserve Active Status List until the last day of the month in which they complete 20 and 24 years (respectively) of federal commissioned service. Continued officers will be eligible for promotion consideration for as long as they remain on the Reserve Active Status List. Officers selected for continuation only meet one continuation board for the same rank, which will take them to their maximum time of federal commissioned service.

Attachment 5 is a listing of all officers who served on the board and Attachment 6 is a statistical summary of the board.

The codes listed in the PC (promotion category) column on the select and nonselect lists are defined as follows:

ELIGIBILITY CRITERIA

Air Force Reserve JAG and Chaplain captains and majors who are on the Reserve Active Status List (RASL) and assigned to the Selected Reserve (SELRES) or limited extended active duty (LEAD) period with the active component of the USAF for periods of less than 3 years as of the board convening date. Other Than Selected Reserve (OTSR) officers are ineligible for continuation consideration. The boards will consider all twice-deferred, SELRES or former Air Force Reserve LEAD line and nonline captains and majors who fail promotion selection to major and lieutenant colonel for two or more times and are required to be removed from an active status due to their promotion non-selections. The boards will not consider captains and majors who have previously been offered continuation in the AFR in the grade of captain and major. Selected captains and majors may not be continued beyond the last day of the month in which they complete 20 and 24 years (respectively) of total federal commissioned service. No officer will be continued beyond the last day of the month in which that officer becomes 60 years of age.
