SUBJECT: Air Force Lieutenant Colonel Selective Continuation Boards, 21-25 October 2002

Attached are alphabetical listings of the Air Force Reserve officers selected or nonselected for continuation on the Reserve Active Status List (Atch 1). The continuation board convened in accordance with Title 10 U.S.C.; DoD Directive 1320.8; Air Force Policy Directive 36-26; and Air Force Instruction 36-2504 at Headquarters Air Reserve Personnel Center (HQ ARPC).

Public release is 9 January 2003 and was announced by DMS message. Do not inform officers of their status until public release date. Until that time, all attachments are "For Official Use Only" and may be seen only by those officials who are responsible for administrative processing of the lists. In accordance with the Privacy Act of 1974, disclosure of the select list containing Social Security Numbers (SSNs) without the consent of all individuals on the list is an invasion of privacy. As a result, even though the "For Official Use Only" designation on the select lists may be deleted on the public release date, the lists cannot be publicly released unless the SSNs are removed. Individuals selected for continuation will be notified by letter from this headquarters to either accept or decline continuation. **Do not publicly display or release either select or nonselect lists at any time.**

Military Personnel Flights (MPFs) will furnish unit commanders the names of their officers selected and nonselected for continuation. Commanders must continue to evaluate officers and ensure propriety of continuation. If it becomes appropriate to remove an officer's name from a select list, comply with AFI 36-2504 chapter 10; such actions must be initiated prior to officer accepting continuation. Selected lieutenant colonels may be continued on the Reserve Active Status List until the last day of the month in which they complete 30 years of federal commissioned service. Continued officers will be eligible for promotion consideration for as long as they remain on the Reserve Active Status List.

Attachment 2 is a listing of all officers who served on the board and Attachment 3 is a statistical summary of the board.

The codes listed in the PC (promotion category) column on the select and nonselect lists are defined as follows:

A – Line

S – Medical Service Corps

N – Nurse Corps

ELIGIBILITY CRITERIA

Air Force Reserve (USAFR) rated lieutenant colonels and any USAFR lieutenant colonel who own any AFSC where overall Selected Reserve (SelRes) career field officer manning is 90% or less. Eligible officers must be on the Reserve Active Status List (RASL) and assigned to the SelRes or they must be qualified limited extended active duty (LEAD) officers serving with the active component of the USAF for periods of 3 years or less as of the board convening date. NonSelRes officers are ineligible for continuation consideration. The boards will consider all eligible lieutenant colonels in the SelRes or former USAFR officers who are serving in LEAD whose MSDs of 28 total federal commissioned service years expire between 1 January 2003 and 31 December 2003. Selected lieutenant colonels may not be continued beyond the last day of the month in which they complete 30 years of total federal commissioned service. No officer will be continued beyond the last day of the month in which that officer becomes 60 years of age.
