SUBJECT: FY04 Air Force Reserve JAG and Chaplain Major and Lieutenant Colonel Promotion
Selection Boards - V0404B, W0404B, U0404B, V0504A, W0504A, U0504A

Attached are alphabetical listings of the Air Force Reserve officers selected or nonselected for promotion to the grade of major and lieutenant colonel (Atchs 1 through 8). The selection boards convened in accordance with Title 10 U.S.C. and AFI 36-2504 at Headquarters Air Reserve Personnel Center (ARPC).

Public release is 1 July 2003 and was announced by DMS message. Do not inform officers of their status until public release date. Until that time, all attachments are "For Official Use Only" and may be seen only by those officials who are responsible for administrative processing of the lists. In accordance with the Privacy Act of 1974, disclosure of the select list containing Social Security Numbers (SSNs) without the consent of all individuals on the list is an invasion of privacy. As a result, even though the "For Official Use Only" designation on the select lists may be deleted on the public release date, the lists cannot be publicly released unless the SSNs are removed. The nonselect list is provided to permit full accounting for all eligibles by the MPF. **Do not display or release a nonselect list at any time.**

Military Personnel Flights (MPFs) will furnish unit commanders the names of their officers selected and nonselected for promotion prior to the public release date. Commanders must continue to evaluate officers and ensure propriety of promotion. If it becomes appropriate to involuntarily delay an officer's promotion or to remove an officer's name from a select list, comply with AFI 36-2504 chapter 7. Such actions must be initiated prior to effective date of promotion. At the discretion of the selected officer, the immediate commander of officers selected for promotion will advise the officer's employer of his or her selection for promotion (AFI 36-2504, para 5.7).

The Date of Rank (DOR) and Promotion Effective Date (PED) for officers selected from the mandatory board will be the date the officers complete the required time in grade (TIG) or 1 October 2003, whichever is later, as listed below:

RANK	TIG
Major	7 years
Lieutenant Colonel	7 years

Selectees may receive accelerated promotion if they satisfy the eligibility requirements and their commander completes a letter requesting accelerated promotion (AFI 36-2504, Atch 5). The letter must contain a recommended DOR which is no earlier than Presidential approval (if the officer is in the position at that time), or date officer is to be placed in the higher grade position (after Presidential approval). The commander will send the letter to the officer's senior rater for endorsement who will

then forward the request to HQ ARPC/DPBA to arrive not later than 2 business days before the proposed DOR. HQ ARPC/DPBA will publish promotion orders for LEAD officers selected by RASL promotion boards. No other order is required for LEAD officers to assume the higher grade. LEAD officers, promoted by RASL promotion boards, do not have reserve higher-graded position restrictions that could prevent pin-on.

Accelerated promotion requirements are the same as position vacancy (PV) which must include:

Have an outstanding record with at least 50 points during the last full Retirement and Retention (R/R) year.

Be in a valid higher grade reserve position in the nominees Duty Air Force Specialty Code which satisfies the position vacancy criteria of a valid vacancy.

Accelerated promotions are effective upon the date designated by the senior rater, unless the officer does not meet the requirements above. If HQ ARPC/DPBA determines the officer is not qualified for accelerated promotion, the senior rater will be notified.

Attachment 3 & 7 to this letter reflect those officers selected for PV promotion. The PED and DOR for PV selectees will be the date the officers complete the required TIG or Presidential approval, whichever is later as listed below.

Rank	TIG
Major	4 years
Lieutenant Colonel	4 years

For the PV promotion to be effective, officers must be assigned to the position for which recommended. Selectees not in the position for which recommended will be removed from the select list.

If an officer's promotion is not withheld, an officer selected for promotion is considered to have accepted the promotion on the PED unless the officer expressly declines the promotion. An officer must submit a declination statement IAW AFI 36-2504, Chapter 8 no later than 2400 on the day before the PED. Should delay of promotion be appropriate, see AFI 36-2504, Chapter 8.

Orders announcing the promotion will be published and distributed in accordance with AFI 36-2504, para 5.12. Requests for missing orders should be addressed to HQ ARPC/DPSS.

Officers not selected for promotion by the mandatory board are considered "to have failed of selection for promotion" as defined by Title 10 U.S.C. Sec 14501. Officers who have failed of selection from these boards are listed at Attachment 2. Attachment 4 identifies officers nonselected for position vacancy. An officer considered for PV and not selected shall not be considered to have failed selection for promotion IAW Title 10, U.S.C. 14315 (d).

First-time nonselected Air Force Reserve officers will be advised by letter from HQ ARPC/DPB in addition to the notification by their immediate commander.

Officers twice deferred will be notified of their nonselection (HQ ARPC/DPP) and receive a mandatory separation date effective the first day of the seventh month after the month the President approved the results of the promotion board.

Attachment 9 is a listing of all officers who served on the board and Attachment 10 is a statistical summary of board results. In support of the initiative to use the Oath of Office as an option during an officer's pin-on ceremony, a copy is provided at Attachment 11.
